Executive Meeting On Zoom February 27, 2023

Meeting Minutes (Draft)

1. Call to Order: The meeting was called to order at 7:05 pm with Chris Erl in the Chair.

2. Land Acknowledgement:

The Chair read the following acknowledgement:

We take this time to recognize that Strathcona is situated upon the traditional territory of the Erie, Neutral, Huron-Wendat, Mississauga and Haudenosaunee. This land is shared between the Haudenosaunee Confederacy and the Anishinaabe, as acknowledged in the Dish With One Spoon Wampum Belt. That Wampum uses the symbolism of a dish to represent the territory, one spoon to represent that the people are to share the resources of the land, and take only what they need.

3. Approval of Agenda:

The Chair reported that Police Sgt. Asim Butt informed him he could not attend the meeting due to another commitment, so the Crime Manager's Report was struck from the agenda.

5. Updates From Councillor:

Councillor Maureen Wilson gave updates on the following matters:

- A) Access to Victoria Park Field House She said it is normally not her practice to complain or blame city staff for errors in their dealings with the public, but she offered an apology to President Chris E. for the fact that no one got back to him about the delay in making the field house ready for SCC meetings, and promised to rectify the breakdown in communication.
- B) Mural On Outside Field House Wall She said she wants the project to go ahead. She noted an upcoming meeting to work on the mural.
- C) 428 Main St. W. Development She said the developer wants to build an 8 to 10 storey building. New Horizons has applied to the committee of adjustment for a minor variance. (The minor variance for the 10 storey development was accepted by city councillors the same day).

6. President's Report:

Chris E. reported on the following matters:

- A) Fieldhouse for meetings He said the delays in getting the building ready for use after repairs from vandalism is now complicated by the fact that other organizations have applied to use the facility. It is still possible that the SCC can use the space for its purposes. He will keep the Executive informed.
- B) Chris E. thanked Barb, Jen and Ian for putting together the SCC's application for funding for Green projects. The Executive is waiting to see how much it will get.
